

Mango inSchool Photography Privacy Policy

The GDPR is the General Data Protection Regulation which comes into force on 25th May 2018. The purpose is to ensure that all businesses holding personal data have policies and practices in place for managing and handling such data. Mango in School Photography in compliance with GDPR has conducted a full audit of our working practices which will be reviewed regularly. This includes data collection, handling, documentation, processing, storage and deletion procedures. This Privacy Policy governs the manner in which **Mango in School Photography** collects, uses, maintains and discloses information collected from customers. This Privacy Policy applies to all products and services offered by Mango in School Photography.

Personal identification information

We may collect personal identification information from customers in a variety of ways, including, but not limited to, when customers visit or register on our Website, place an order, or in connection with other activities, services, features or resources we make available. Customers may be asked for, as appropriate, name, email address, mailing address, and phone number. Customers may, however, visit our Website anonymously. We will collect and maintain personal identification information from customers only if they voluntarily submit such information to us. Customers at their own discretion can refuse to supply personal identification information, or opt out of our services.

Non-personal identification information

We may collect non-personal identification information about customers whenever they interact with our Website. Non-personal identification information includes but is not limited to the browser name, the type of computer and technical information about customer's means of connection to our Website, such as the operating system, the Internet service provider utilised, and other similar information. We do not access or use this information although our website may gather non-personal identification information.

Web browser cookies

Our Website may use "cookies" to enhance the customer experience. Customers web browsers place cookies on their hard drive for record-keeping purposes and sometimes to track information about them. Customers may choose to set their web browser to refuse cookies, or to alert them when "cookies" are being sent.

How we use customer information

Mango in School Photography collects and uses customer personal information for the following purposes:

To process orders – Our main purpose of data collection is for the sole purpose of fulfilling customer orders. We may use the information customers provide about themselves when placing an order to provide service to that order. We do not share this information with third parties.

To send periodic emails – We may use the email address to send customers information and updates relating to their order. It may also be used to respond to their enquiries, questions, and/or other requests. If customers decide to opt-in to our mailing list, they may receive emails that include company news, updates, related product or service information, etc. If at any time the customer would like to unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email.

How we protect your information

We only collect data that is necessary for processing customer orders. We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorised access, alteration, disclosure or destruction of your personal information.

Sharing your personal information

We do not sell, trade, or rent customers personal identification information to others. We may use third party service providers to help us operate our business, the Website, or to administer activities. We may use third parties for the safe storage of personal information such as email lists but these third parties have no access to the data.

Changes to this privacy policy

Mango inSchool has the discretion to update this policy at any time in line with the GDPR policy. When we do, the most recent revision of this policy will be made available on our Website and we will post a notification on the main page of our Website to notify customers. We encourage customers to frequently check the Website for any changes and to stay informed about how we protect the personal information we collect. You acknowledge and agree that it is your responsibility to review this privacy policy periodically and become aware of modifications.
